- 3. Cool Youth Association for Cultural and Educational Development, having an administrative office at ul. Partizanska N.2, 2000 Shtip, represented by Mia Efremova, President.

AGREEMENT OF COOPERATION

Article 1

The present Agreement shall regulate the rights and duties of the three parties' signatories involved in the implementation of the project *Move in the Next European Youth Strategy (M.I.N.E)* from the period of January until December 2018.

Article 2

Signatories shall co-operate in the following areas:

- Cooperation in the realization of the project tasks;
- Participation in the meetings within the project activities;
- Assigning responsible persons relevant for this project;
- Student inclusion in the project implementation;
- Organization and technical support of the workshop in Macedonia;
- Preparation of document for self-employment possibilities of students at UGD and preparation of suitable strategy;
- Drawing up a document with proposals and operative suggestions in order to enrich the subsequent program regarding Youth: R.E.S.T.A document. This document contains the key concepts emerged from the common reflection (Reflect), the innovative contents discussed (Talk), the operative proposals and the programmatic points to be submitted to politicians (local level, European national level) and to the territorial stakeholders (Suggest), the resources and personal possibilities for the concrete realization of the proposals presented (Engage), the list of activities to be put into practice to facilitate the transmission of the document and its best diffusion (Achieve);
- Increasing European awareness and the active involvement of participants in designing and implementing processes and paths aimed at achieving the objectives of the EU;
- Stimulation of the participation of young people at risk of social exclusion in local decision-making processes to increase their active and conscious citizenship;

Article 3

The parties' signatories will appoint the coordinators involved in the project, students that will participate in the activities, which shall ensure that the Project activities are implemented adequately and in a timely fashion.

Article 4

All details and the realization of the individual activities defined by this agreement shall be discussed and adjusted by parties' signatories.

Article 5

The parties' signatories shall consent to mutually inform each other about all circumstances important for the realization of this agreement.

Article 6

All possible amendments and additions to this agreement as well as other questions related to the subject of this agreement shall be concluded in writing and annexed to this agreement.

Article 7

This agreement shall be concluded for an indefinite period of time. Each partner may cancel the agreement in writing; the cancellation period shall be six months. This agreement shall cease to apply at the end of the cancellation period, provided that the annual program of cooperation has been carried out.

Article 8

The agreement shall go into effect when signed by the legal representatives of the three partners. It is signed in six copies, where all have a nature of the original and where each signatory receives two copies.
