9.30 -10.45 Panel 1: Externalization of EU Asylum and Migration Policy: Questioning the Legal

This panel will discuss externalization of EU asylum and migration policies and their impact upon human rights, but it will also debate some critical aspects on migrations at sea. It will question EU's policy approaches as regards to cooperation with third countries, identifying human rights obligations owed to third-country nationals, assessing policy instruments, and determining the adequacy of accountability mechanisms available in case of potential violations. It will examine the concept of 'externalization' and the transfer of legal responsibility for examining asylum claims to third states through bilateral instruments. Moreover, it will explore core issues such as criminal jurisdiction, the principle of 'non-refoulment' and obligation to assistance and the prohibition of illegal access to the territory, through the prism of Italian and EU policy.

11.00 - 12.30 Panel 2: Migration and asylum in Western Balkan countries: Shaping public perceptions and exploring the 'security – rule of law' dichotomy

Since the Refugee crisis in 2015, migration and asylum have remodeled the agenda of Western Balkan countries, impacting deeply upon the individual and the society, but also upon state security and the rule of law. In that regard the panel will discuss different perceptions of migrants and asylum seekers in the Balkans, and it will look at episodes of hate crime on grounds of refugee or migrants' status on the Balkan route, pointing out the existing standards for prevention and protection and key challenges. Moreover, the panel will discuss EU's collaboration and solidarity towards North Macedonia in the field of asylum and migration, raising questions about effective solidarity towards third countries, as well as it will examine the process of screening procedures on borders in North Macedonia, tracing possible shortcomings and good practices in reference to protection of human rights.

13.30-14.45 Panel 3: Migration and Asylum in North Macedonia: Balancing Rights, Freedoms, Obligations and Security

This panel represented by experts from the main stakeholders in North Macedonia in migration and asylum, will discuss policies, perceptions, challenges and shortcomings in migration and asylum in the country, as well as cooperation with the European Union and third countries and organizations. It will be referred to the UNCHR work worldwide and in North Macedonia concerning international protection of refugees and fundamental principles. Attention will be given to the Macedonian asylum and refugee protection system outlining current challenges, shortcomings, and perspectives. Furthermore, the challenges and the impact of the COVID – 19 pandemics will be discussed, both in relation to protection and adaptability of actions conducted by IOM – Skopje to protect and assist migrants and assist people on the move while not being present in the camp, as well as, in general, in relation to protection of human rights of migrants and refugees in North Macedonia and the Balkan Route and the challenges that it brings to stakeholders.
