# LEGAL NATURE OF THE PUBLIC PRIVATE PARTNERSHIP

- TYPE OF AGREEMENT THAT REGULATES LONG-TERM ( 35+) COOPERATION BETWEEN THE PUBLIC PARTNER AND THE PRIVATE PARTNER
- DETERMINIZING WHO IS PUBLIC WHO IS PRIVATE PARTNER.
  - INCLUDING ONE PRIVATE ( NATURAL OR LEGAL PERSON NATIONAL /INTERNATIONAL) AND ONE PUBLIC (THE STATE, THE MUNICIPALITY, CITY OF SKOPJE AND THE MUNICIPALITIES IN CITY OF SKOPJE, PUBLIC ENTERPRISES, PUBLIC AGENCIES, PUBLIC INSTITUTIONS AND BODIES, LEGAL ENTITIES WITH PUBLIC POWERS AND AUTHORITIES) SIDE OF THE AGREEMENT
- REGULATES THE WAY OF USE AND DISTRIBUTION OF THE PUBLIC SERVICES AND GOODS
- TERMINATION OF THE AGREEMENT
- *SUI GENERIS* AGREEMENT

# REGISTER OF PUBLIC PRIVATE PARTNERSHIPS

- IN EXCEL TABLE AT THE WEB PAGE OF THE MINISTRY OF ECONOMY
- IN THE PERIOD ( 2012-2022) THERE ARE 42 REGISTERED CONCESSIONS AND PPP
- LEADING SECTOR IS HYDRO POWER PLANTS ,
- **ONLY ONE PPP IN HEALTHCARE**, SIGNED AS AGREEMENT FOR PUBLIC PROCUREMENT SERVICE IN DECEMBER 2019, AND REGISTERED IN JUNE 2020 . AMOUNT OF 16.100.000 EUROS

# ADVANTAGES

- REDUCES THE BUDGET EXPENDITURES FOR CAPITAL INVESTMENTS,
- ENABLES COOPERATION BETWEEN THE PUBLIC AND THE PRIVATE SECTOR,
- IMPROVES THE QUALITY OF THE PUBLIC SERVICES
- INCREASE THE OPPORTUNITIES FOR NEW JOBS
- RESOURCE AND ASSET MANAGEMENT

# DISADVANTAGES

- HIGH RISKS FOR INVESTORS
- LACK OF INTEREST TO INVEST IN THE HEALTHCARE SECTOR
- POLITICAL INFLUENCE
- ABSENCES OF MONITORING OF THE CONCLUDED AGREEMENTS OF PPP
