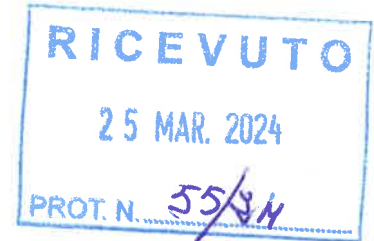





<p>History of cooperation with the applicants</p>	<p>The Faculty has been partner of the project “MODEL EU”, carried out in 2022 in the country by CISS. During the project the researchers of the University introduced the topic of circular economy among youth and students from different areas of the country; moreover, the university selected the students who took part in a non-formal education laboratories aimed at stimulating the critical thinking and the active citizenship of the youth.</p>
<p>Role and involvement in preparing the proposed action</p>	<p>The Faculty contributed to identify the proposed activities. In particular researchers specialized in circular economy designed the training contents which in the framework of <u>Activity 2.1</u> and <u>Activity 2.2</u>. will be addressed to local youth. The Faculty has also contributed to identify some relevant logistic aspects of the action.</p>
<p>Role and involvement in implementing the proposed action</p>	<p>The Faculty of Tourism and Business Logistics will be involved in the project implementation at different levels: firstly, the research team of the Faculty will contribute with their studies and visions to share information on the potentialities for the development of the green economy in the South-Eastern Region. Secondly, the expert in circular economy researching at the Faculty will run training classes on this relevant topic in the framework of the above-mentioned Activities (2.1 and 2.2.). Since the Faculty is committed to generate new green jobs in the region, it will host one of the hubs of the CSO-led start up at the premises of Gevgelija (<u>Activity 2.3</u>). The students of the Faculty will be involved, as trainers, in the environmental education laboratories targeting the primary and secondary students of the region in the context of the <u>Activity 3.1</u>. The Faculty will promote the annual event celebrated in Strumica on the occasion of the World Environment Day (<u>Activity 1.4</u>).</p>
