- Participation in the initial team kickoff meeting (21.11.2024).
- Involved in creating documents and setting the groundwork for future activities.

- Prepared and presented a presentation introducing the UGD WP8 team, developed in coordination with colleagues at the University "Goce Delčev" (UGD).

Involvement in project activities 2024 - 2025

- Analyzed the ACE2EU application document, identified key milestones, and contributed to the review and refinement of essential documents such as the Identity Guidelines and Communication Strategy.
- Provided input and proposals for the development of the final ACE2EU Identity Guide and ensured UGD's branding materials, including vector logo files, were submitted as required.
- Participated in regular WP8 meetings, where we discussed ongoing and upcoming activities, including promotional ideas for the Alliance and strategic planning for content dissemination.
- Created multiple PowerPoint presentations—highlighting both institutional capacities and best practices in content creation.
- Took part in the conceptual development of the podcast format, initiated brainstorming sessions with the team, and coordinated the creation and sharing of podcast ideas and plans.

Involvement in project activities 2024 - 2025

- Developed and sent input for the ACE2EU Promotional Strategy and prepared a tailored Communication Strategy for UGD, aligning internal efforts with Alliance-wide goals. These strategic documents aim to reinforce visibility and coherence across all partner institutions.
- Coordinated UGD students' participation in the ACE2EU Virtual Coffee event.
- Took part in both planning and execution, as well as follow-up discussions on enhancing student engagement within the Alliance. During one of the Virtual Coffees, the Microsoft internal communication platform was introduced, marking a step forward in strengthening inter-institutional collaboration.
- Supported the coordination and distribution of ACE2EU promotional materials, such as banners, through collaboration with external partners.
- Initiated the idea for a promotional video involving president Joao Moutao to enhance Alliance visibility.
- Contributed to external outreach by drafting a PR text promoting the Alliance for publication on the online educational portal *Fakulteti.mk* (<https://www.fakulteti.mk/news/28042025/pridruzhi-mu-se-na-univerzitetot-goce-delchev---shtip-i-stani-del-od-evrofskata-akademska-idnina-preku-ace2eu>).
